To the extent that any document, whether made, maintained or kept in paper, electronic or digital form, that includes information relating to the compensation and/or benefits paid or to be paid to each full-time or part-time employee for any of the school years and/or fiscal years identified above, also contains information that is not subject to disclosure under CORA, I ask that the public record be produced with the information not subject to disclosure redacted from the record and a statement as to the subject matter of the information redacted.

If you deny me access to any of the requested records as to any of the full-time or part-time employee employed by the Adams County School District 50 during any of the school years and/or fiscal years identified above, I request, pursuant to C.R.S. § 24-72-204(4), that you provide me with a written statement identifying the record not produced and stating the grounds for the denial of each identified record with respect to which I am denied access, which statement shall cite the law or regulation under which access is denied.
