MOTION TO TEMPORARILY SEAL ALL DOCUMENTS OF RECORD	

HEIDI S. McCOLLUM, District Attorney in and for the Fifth Judicial District, State of Colorado, hereby moves this Honorable Court to temporarily seal all documents of record in the above captioned matter. As grounds for this request, the People state the following:

1. Contained within the documents of record herein are facts regarding the investigation surrounding the charge of menacing (F5) against the defendant. Defendant is a prominent member of the Summit County community and a public official in and for the 5th Judicial District, State of Colorado. The release at this time of any of the documents of record in this matter could result in disclosure of information that could result in destruction, or secreting evidence and tampering with identified and unidentified witnesses which could jeopardize the ongoing investigation and/or interfere with the rights of the defendant, including irreversible harm to reputation, and the defendant's and the People's right to a fair trial.

2. Further, disclosure of information contained in these documents and affidavits would at this time be contrary to public interest as provided in §24-72-305, C.R.S.

WHEREFORE, the People respectfully request that all documents of record in the above captioned matter be temporarily sealed and remain sealed until further order of the Court.
